## TERMS & CONDITIONS FOR TRANSPORTATION SERVICE

Parents are to review the following conditions with their children before using the LFT/ Magic Bus service.

- Neither The Magic Bus Company nor the LFT will be liable for delays caused by accidents, breakdowns, detours, bad highway conditions, snowstorms, traffic congestion, or any other conditions beyond our control, and cannot guarantee the specified time of arrival or departure. The Magic Bus Company and LFT will, nevertheless, endeavour to maintain the published schedule.
- The Magic Bus Company and LFT are only responsible for delivering children to the designated pick-up and drop-off locations
- Any interior or exterior damage caused by the LFT passengers shall be the responsibility of the students and their families, including the cost to the carrier for repairs and loss of service due to such damage. The students will be responsible for the general cleanliness of the bus while on route and drop-off. Failing this, an additional cleaning fee will be assessed and submitted to the student's caregivers. Payment due upon receipt (payable to Magic Bus)
- Students are required to remain seated during the entire trip and avoid any noise that would disrupt the bus driver and jeopardize the other students safety  
The driver, with the supervisor agreement and after contacting the parents/guardians, has the right to deny transportation to any disruptive person who is abusive or poses a safety hazard to other passengers. There will be no refund.
- It is agreed that neither the Magic Bus Company, the Lycée Français de Toronto, nor supervisor, directors, officers, employees or agents, will be liable for any injury, damage or losses to the person or property of my child.
